INTRODUCTION

CODES OF PRACTICE

The WSAA National Codes have been developed to provide Designers, Contractors and Contract Administrators with single standard technical reference document. By having these single codes for the Australian Water Industry the following significant benefits will flow:

- Quality improvement.
- Cost Reduction in planning, design and construction activities.
- More efficient evaluation and acceptance of new technology and innovative solutions.
- Transparency of the interfaces between the Water Agencies and their strategic suppliers of products and services.

These Codes do not:

- provide administrative or process guidance that is specific to each Water Agency.
- address private water reticulation and/or sewers connected to the Water Agencies systems.

Where any conflict exists, SA Water's "Supporting Documentation" takes priority over the Codes of Practice requirements.

PRODUCT AUTHORISATION

To ensure conformity and quality of SA Waters reticulation systems, only products authorised by SA Water are to be used within SA Water infrastructure.

Requests for Authorisation are handled in two ways:

- Apply directly to SA Water Infrastructure Standards Unit.
- Obtain a WSAA Product Appraisal report as acceptable for use in Water Industry and apply to SA Water for authorisation (Preferred Option).

Applications will only be accepted directly from the manufacturer or an authorised agent in the case of interstate or international manufacturer.

It must be understood that most construction work is now done by contractors and they are free to purchase Authorised Items from **any supplier** who sells them. Purchases will generally be based on the price of the item and/or the service provided and therefore inclusion in the List **is not a guarantee of sales**.
